15	SEC. 3. GAO STUDY ON EMERGENCY AIR AMBULANCE

17	Not later than 1 year after the date on which data
18	begins to be collected pursuant to the provisions of, and
19	amendments made by, section 106 of division BB of the
20	Consolidated Appropriations Act, 2021 (Public Law 116-

6	(4) the adequacy of Medicare payments for

9	nishing such services; and
10	(6) recommendations on improving the fee
11	schedule under section 1834(l) of the Social Security
12	Act (42 U.S.C. 1395m(l)) for air ambulance serv-
13	ices.
