As I travel throughout
Washington and across
the country, I consistently hear
from many of you who are
struggling with the rising cost
of living. I'm fighting against
policies that have raised
prices while championing
legislation to help make sure
you have the tools and
opportunities to succeed.

Combating Trump's Tariffs

President Trump's illegal tariffs have raised costs on the average family by \$1,700 this year. That's why I authored legislation requiring the president come to Congress, which is current law, before he can enact sweeping tariffs and signed a legal brief to the Supreme Court arguing that they should be overturned.

Fighting Rising Costs

This year, Republicans enacted massive tax cuts for the wealthy and large corporations. They paid for them by gutting Medicaid and Affordable Care Act coverage, increasing hunger, driving up energy bills, and raising taxes on working Americans.

I pushed instead for policies that would help middle-class families, like reinstating the expanded Child Tax Credit and extending the Affordable Care Act tax credits.



FIGHTING FOR YOU

Addressing Housing Affordability

Limited affordable housing supply is one of the major reasons rent prices are increasing. I introduced legislation that would create over 1.5 million more affordable homes.





Despite these polarizing times in Congress, I continue to advance policies that would make common sense changes to the programs and services that support you.

Cutting Health Care Red Tape for Seniors

Health insurers often use 'prior authorization' to delay or deny needed care, harming patients. I introduced bipartisan legislation to streamline this process in Medicare Advantage. I also introduced a bill to stop the Trump administration from forcing traditional Medicare patients in Washington to be subject to prior authorization for certain services starting in 2026.



Protecting Your Data Privacy

President Trump gave Elon Musk and the 'Department of Government Efficiency' unprecedented access to your sensitive personal, financial, and health information with little oversight or accountability. I led the call for an investigation to determine who was granted access to this data and how your information was used.
