

## Population and Housing Narrative Profile 2009-2013 American Community Survey 5-Year Estimates

While the ACS produces sample-based population group and housing estimates used in this report, the Census Bureau's Population Estimates Program produces and disseminates official estimates of the population for the nation, states, counties, cities and towns, as well as estimates of housing units for states and counties. ### Geography: Redmond, Washington

#### ► Households and Families

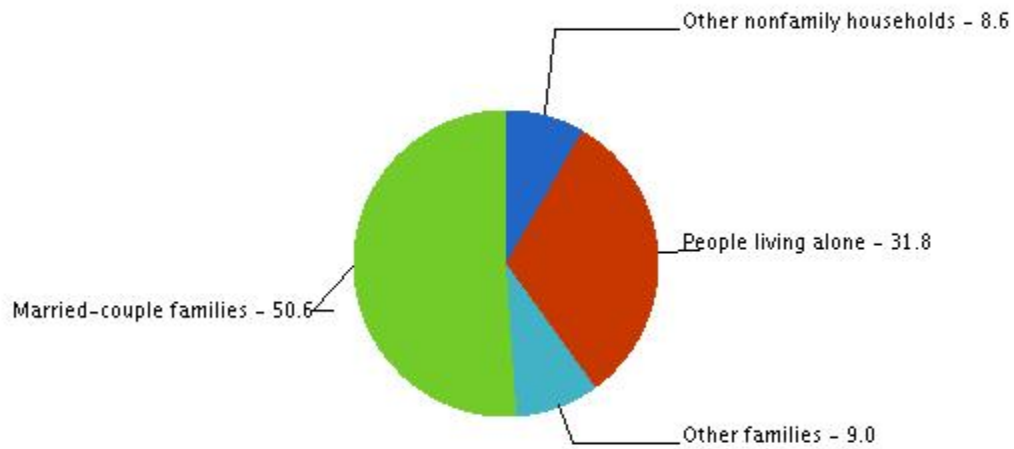

In 2009-2013 there were 23,600 households in Redmond, Washington. The average household size was 2.3 people.

Families made up 60 percent of the households in Redmond, Washington. This figure includes both married-couple families (51 percent) and other families (9 percent). Of other families, 4 percent are female householder families with no husband present and own children under 18 years. Nonfamily households made up 40 percent of all households in Redmond, Washington. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

In Redmond, Washington, 31 percent of all households have one or more people under the age of 18; 16 percent of all households have one or more people 65 years and over.

Among persons 15 and older, 55 percent of males and 58 percent of females are currently married.

In Redmond, Washington, 387 grandparents lived with their grandchildren under 18 years old. Of those grandparents, 37 percent of them had financial responsibility for their grandchildren.

## ► Nativity and Foreign Born

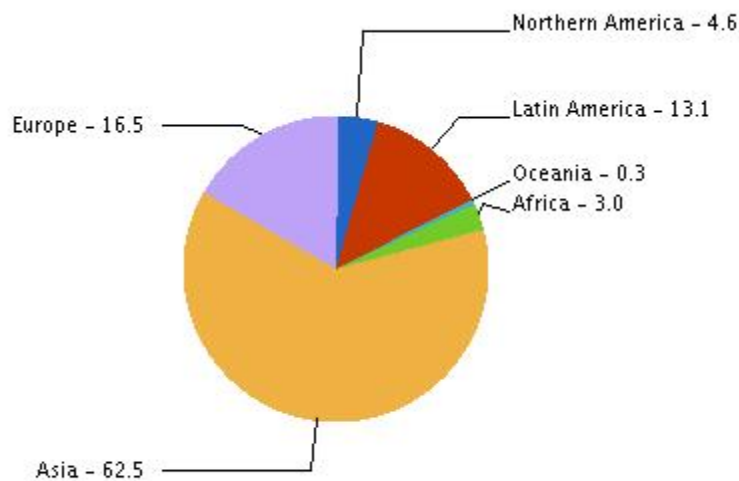

An estimated 66 percent of the people living in Redmond, Washington in 2009-2013 were native residents of the United States and 30 percent of these residents were living in the state in which they were born.

An estimated 34 percent of the people living in Redmond, Washington in 2009-2013 were foreign born. Of the foreign born population, 30 percent were naturalized U.S. citizens, and 86 percent entered the country before the year 2010. An estimated 14 percent of the foreign born entered the country in 2010 or later.

Foreign born residents of Redmond, Washington come from different parts of the world.

Region of Birth for the Foreign Born Population in Redmond, Washington in 2009-2013

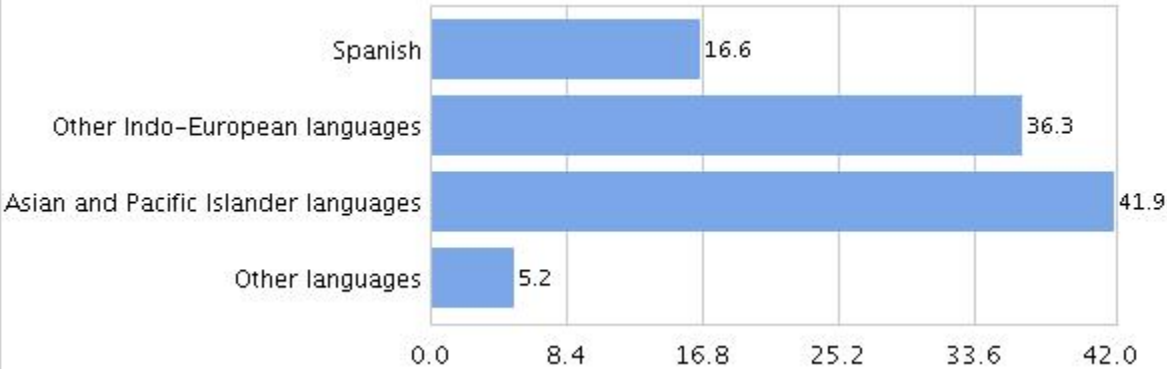


## ► Language

---

Among people at least five years old living in Redmond, Washington in 2009-2013, 38 percent spoke a language other than English at home. Of those speaking a language other than English at home, 17 percent spoke Spanish and 83 percent spoke some other language; 32 percent reported that they did not speak English "very well."

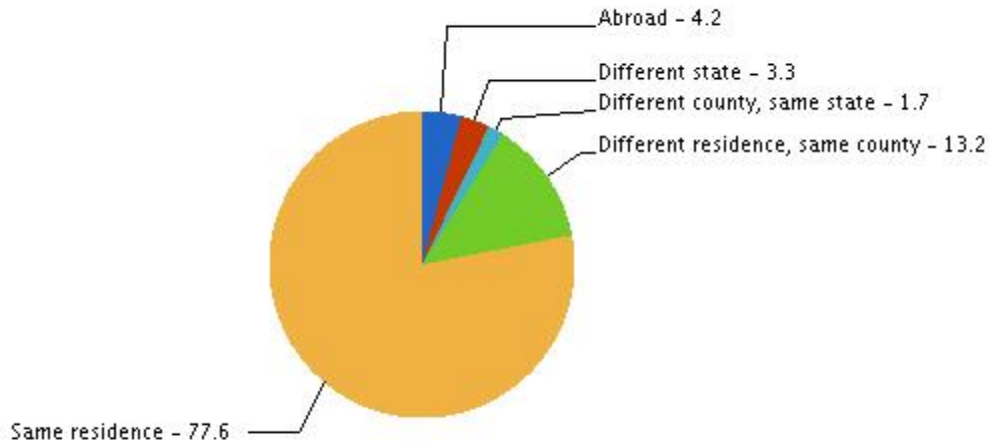
Percent of the Population 5 years and over who Speak a Language other than English in Redmond, Washington in 2009-2013



**► Geographic Mobility**

In 2009-2013, 78 percent of the people at least one year old living in Redmond, Washington were living in the same residence one year earlier.

Geographic Mobility of Residents of Redmond, Washington in 2009-2013

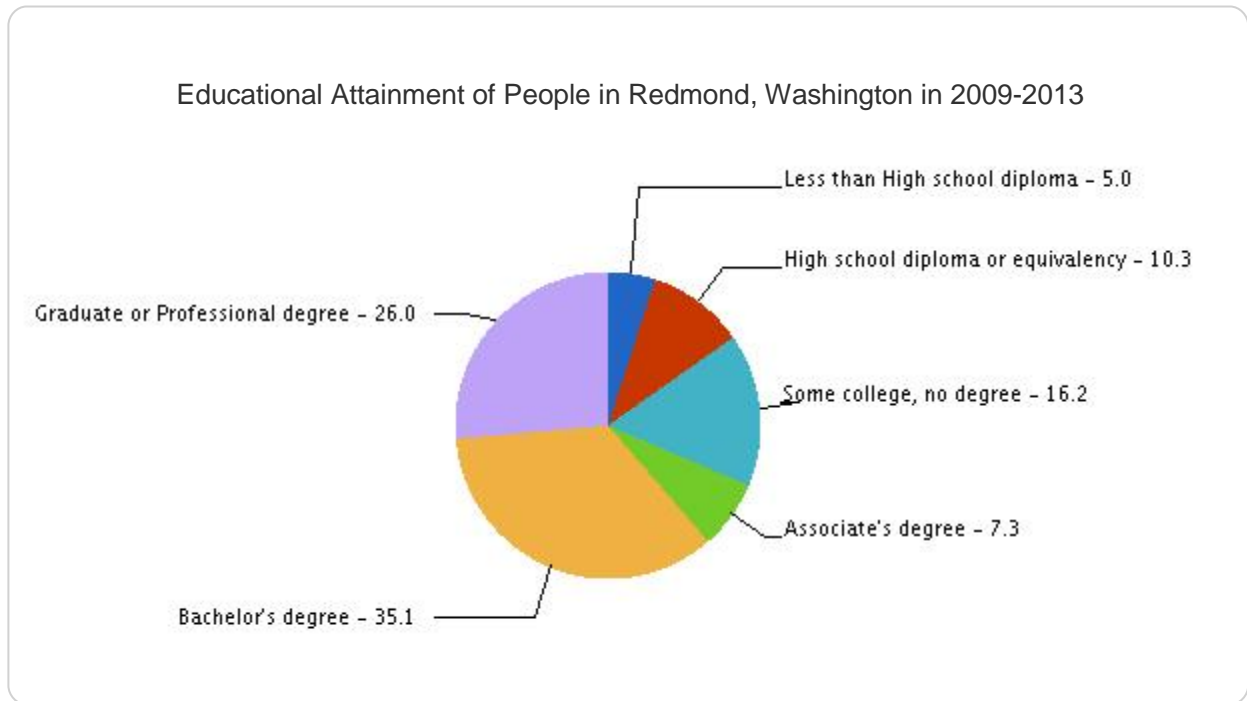


## ▶ Education

---

In 2009-2013, 95 percent of people 25 years and over had at least graduated from high school and 61 percent had a bachelor's degree or higher. An estimated 5 percent did not complete high school.

The total school enrollment in Redmond, Washington was 12,400 in 2009-2013. Nursery school and kindergarten enrollment was 2,200 and elementary or high school enrollment was 7,000 children. College or graduate school enrollment was 3,200.



## ▶ Disability

---

In Redmond, Washington, among the civilian noninstitutionalized population in 2009-2013, 8 percent reported a disability. The likelihood of having a disability varied by age - from 3 percent of people under 18 years old, to 5 percent of people 18 to 64 years old, and to 40 percent of those 65 and over.

## ▶ Employment Status and Type of Employer

---

In Redmond, Washington, 67 percent of the population 16 and over were employed; 29 percent were not currently in the labor force.

An estimated 88 percent of the people employed were private wage and salary workers; 7 percent were federal, state, or local government workers; and 4 percent were self-employed in their own (not incorporated) business.

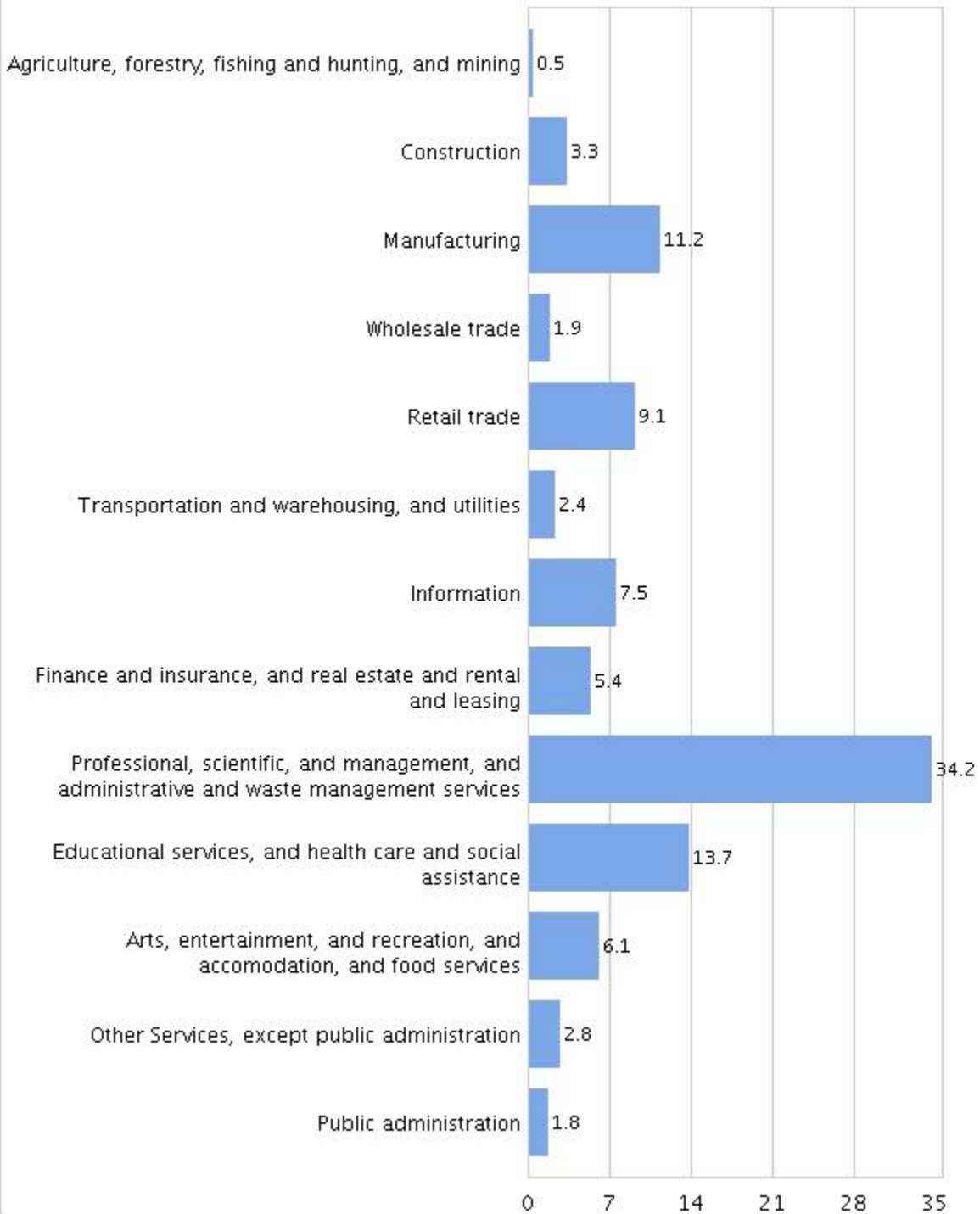

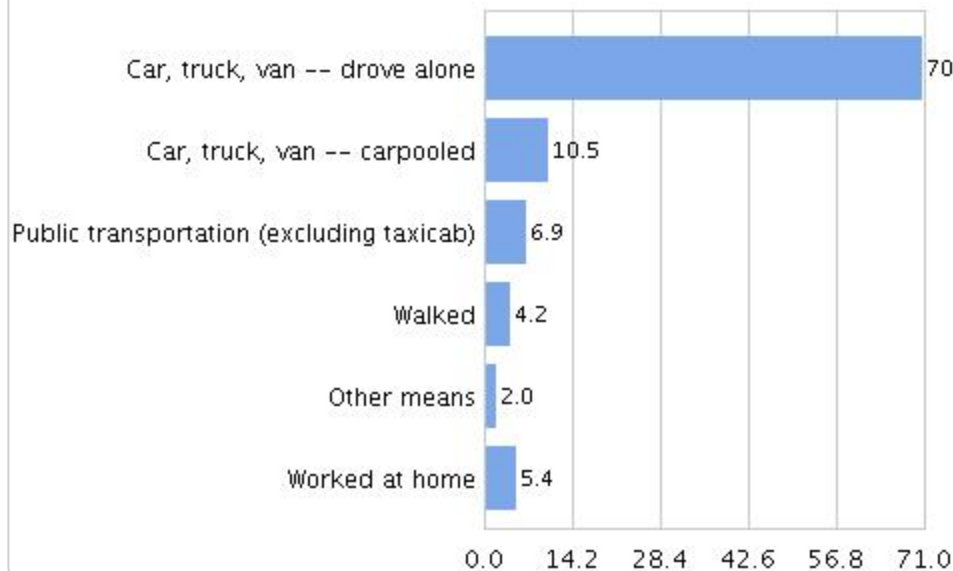

## ► Commuting to Work

An estimated 71 percent of Redmond, Washington workers drove to work alone in 2009-2013, and 11 percent carpoolled. Among those who commuted to work, it took them on average 21 minutes to get to work.

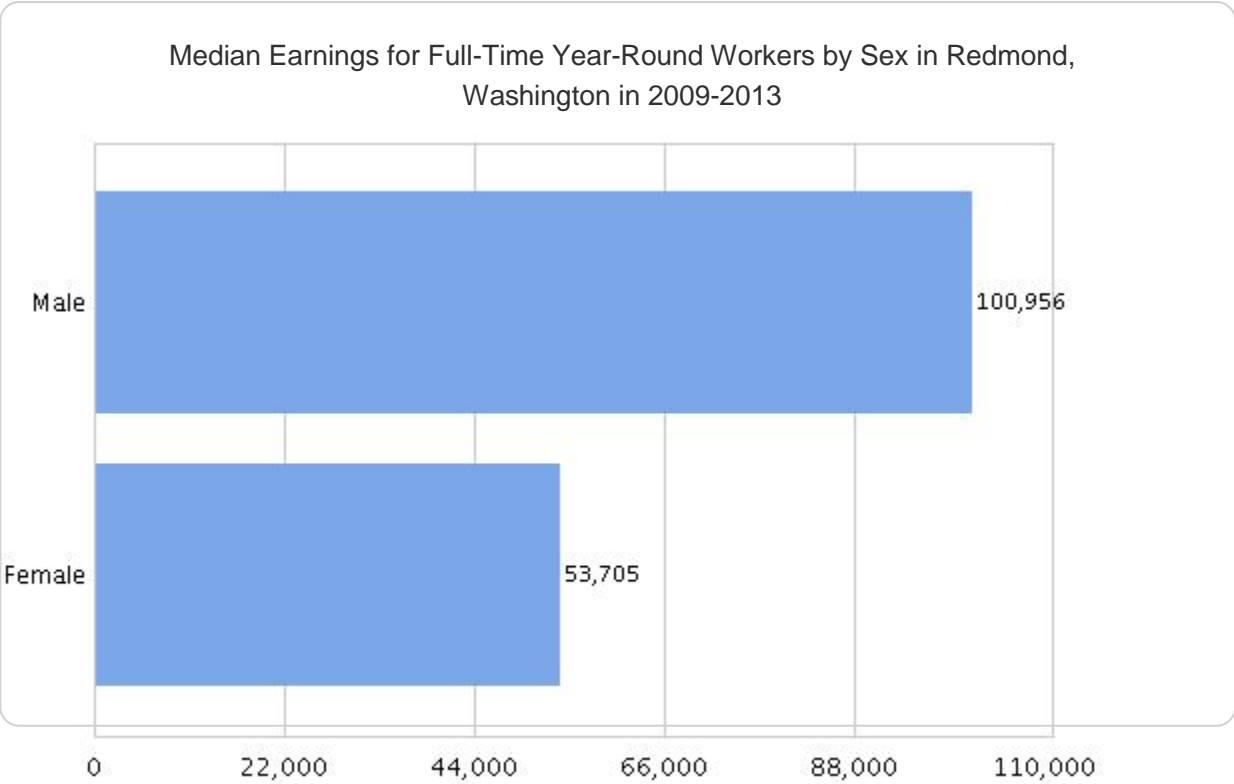
Percent of Workers 16 and over Commuting by Mode in Redmond, Washington in 2009-2013





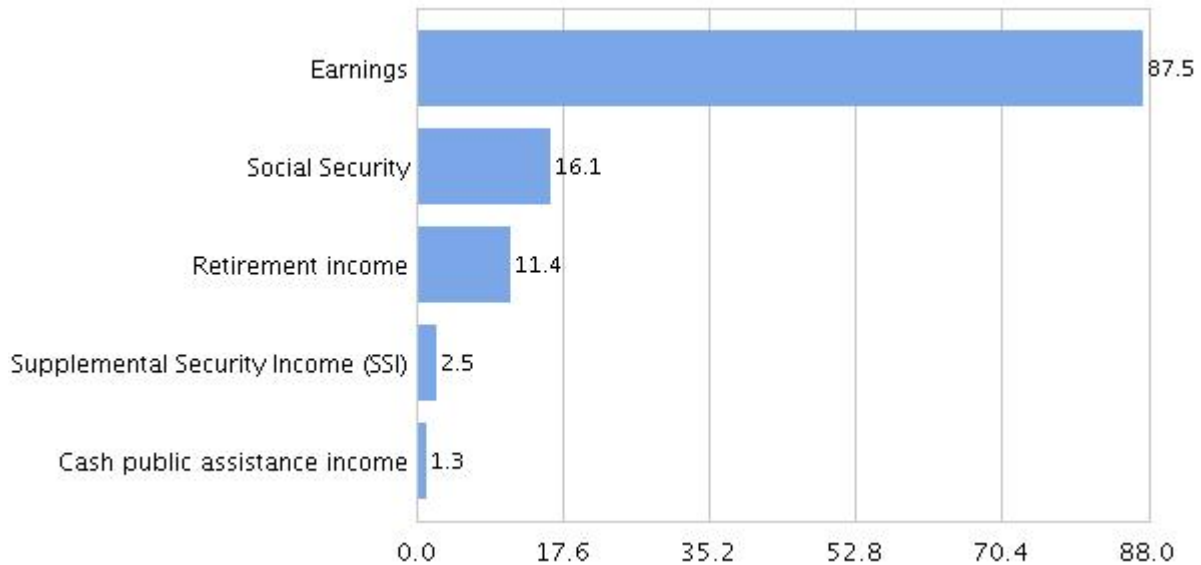
## ► Income

The median income of households in Redmond, Washington was \$96,183. An estimated 6 percent of households had income below \$15,000 a year and 25 percent had income over \$150,000 or more.



An estimated 88 percent of the households received earnings and 11 percent received retirement income other than Social Security. An estimated 16 percent of the households received Social Security. The average income from Social Security was \$18,806. These income sources are not mutually exclusive; that is, some households received income from more than one source.

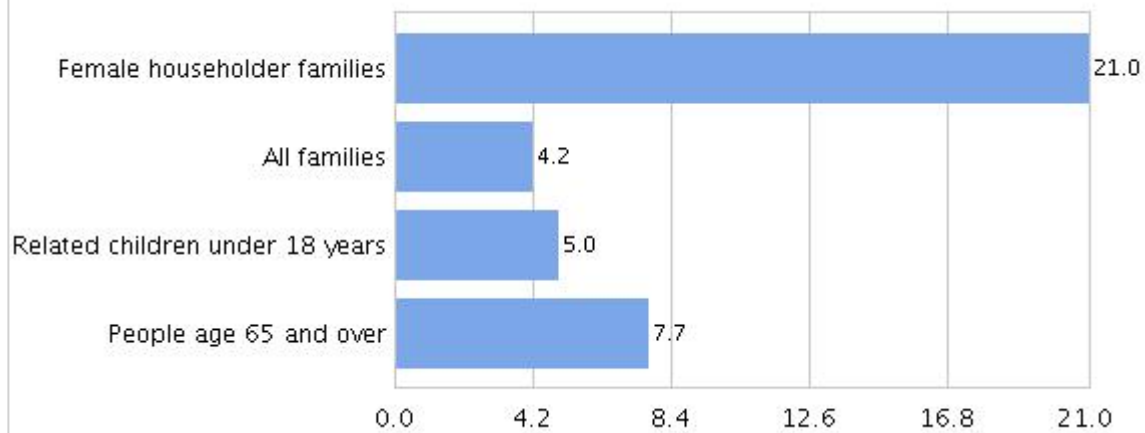
Proportion of Households with Various Income Sources in Redmond, Washington in 2009-2013



### ► Poverty and Participation in Government Programs

In 2009-2013, 7 percent of people were in poverty. An estimated 5 percent of related children under 18 were below the poverty level, compared with 8 percent of people 65 years old and over. An estimated 4 percent of all families and 21 percent of families with a female householder and no husband present had incomes below the poverty level.

## ► Health Insurance

---

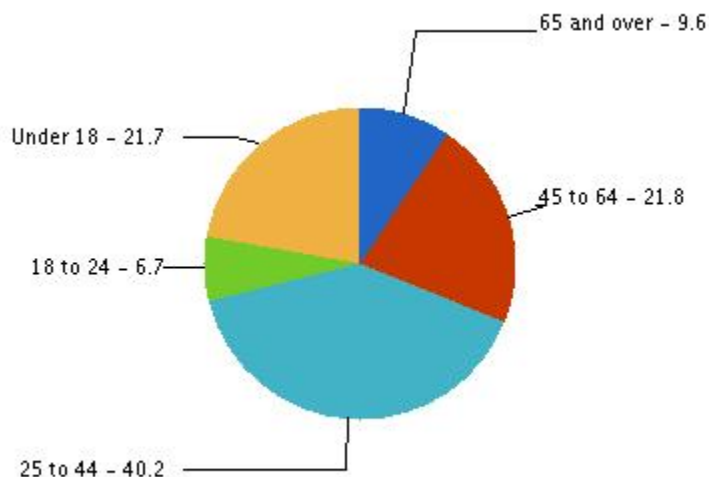
Among the civilian noninstitutionalized population in Redmond, Washington in 2009-2013, 92 percent had health insurance coverage and 8 percent did not have health insurance coverage. For those under 18 years of age, 2 percent had no health insurance coverage. The civilian noninstitutionalized population had both private and public health insurance, with 86 percent having private coverage and 14 percent having public coverage.

## ► Population

---

In 2009-2013, Redmond, Washington has a total population of 55,500 -- 26,500 (48 percent) females and 29,000 (52 percent) males. The median age was 34.8 years. An estimated 22 percent of the population was under 18 years and 10 percent was 65 years and older.

Age Distribution of People in Redmond, Washington in 2009-2013

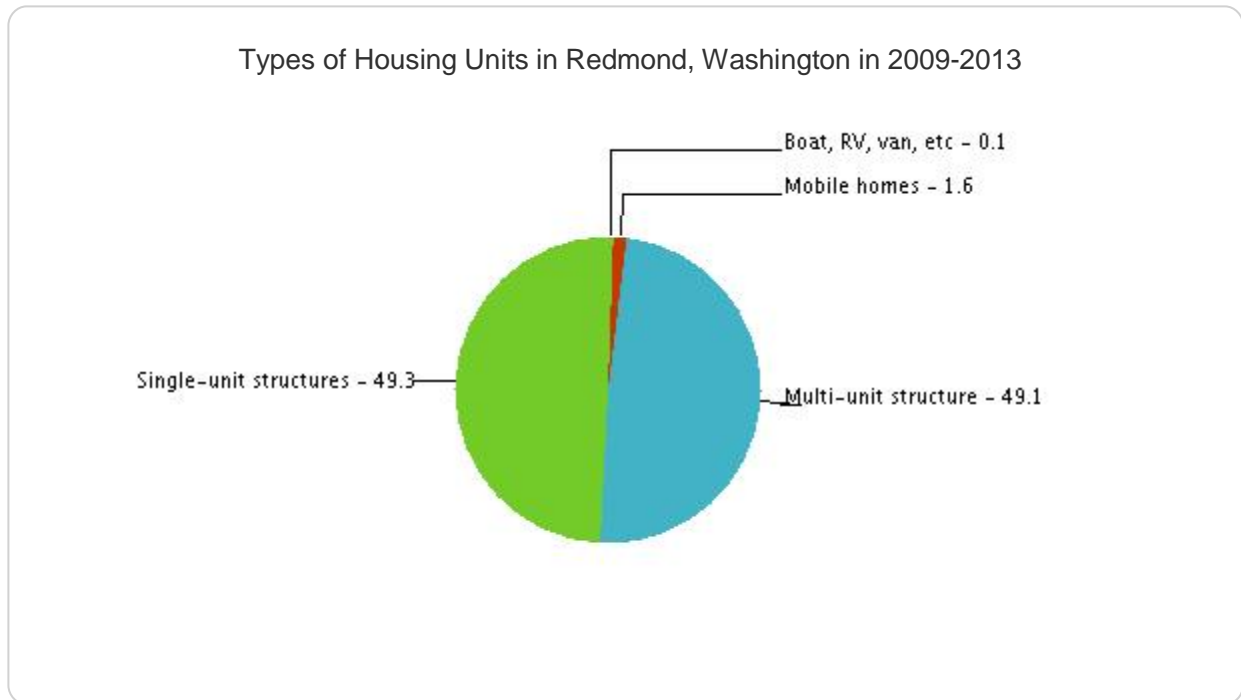


For people reporting one race alone, 67 percent were White; 2 percent were Black or African American; less than 0.5 percent were American Indian and Alaska Native; 27 percent were Asian; less than 0.5 percent were Native Hawaiian and Other Pacific Islander, and 3 percent were some other race. An estimated 5 percent reported two or more races. An estimated 9 percent of the people in Redmond, Washington were Hispanic. An estimated 59 percent of the people in Redmond, Washington were White non-Hispanic. People of Hispanic origin may be of any race.

## ► Housing Characteristics

---

In 2009-2013, Redmond, Washington had a total of 24,900 housing units, 5 percent of which were vacant. Of the total housing units, 49 percent were in single-unit structures, 49 percent were in multi-unit structures, and 2 percent were mobile homes. An estimated 43 percent of the housing units were built since 1990.



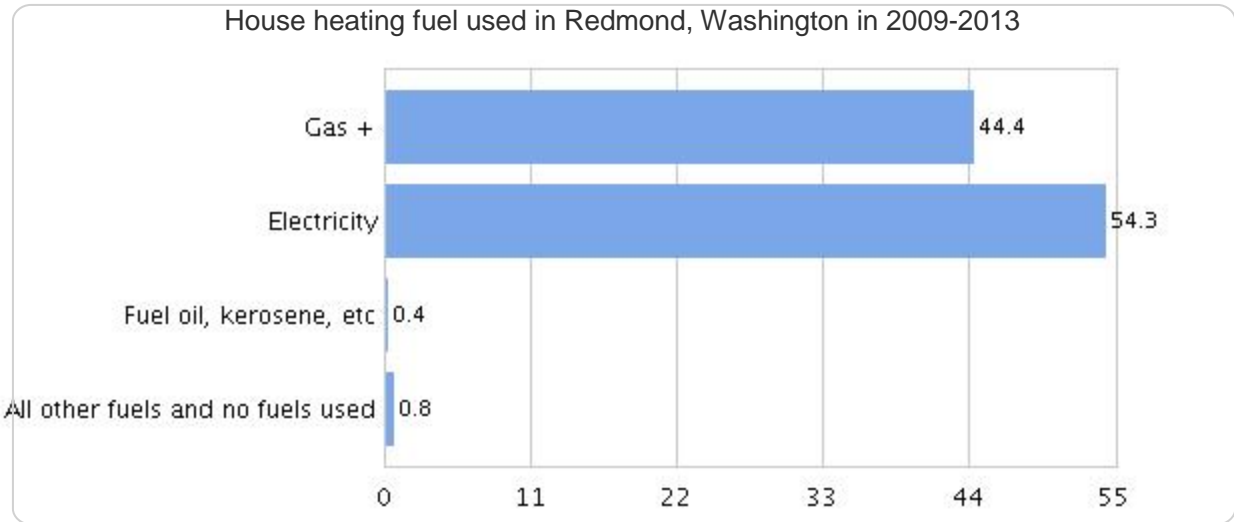
The median number of rooms in all housing units in Redmond, Washington is 5. Of these housing units, 48 percent have three or more bedrooms.

## ► Occupied Housing Unit Characteristics

---

In 2009-2013, Redmond, Washington had 23,600 occupied housing units - 12,200 (52 percent) owner occupied and 11,400 (48 percent) renter occupied. An estimated 77 percent of householders of these units had moved in since 2000. An estimated 78 percent of the owner occupied units had a mortgage. An estimated 2 percent of the households did not have telephone service. An estimated 7 percent had no vehicles available and another 12 percent had three or more.

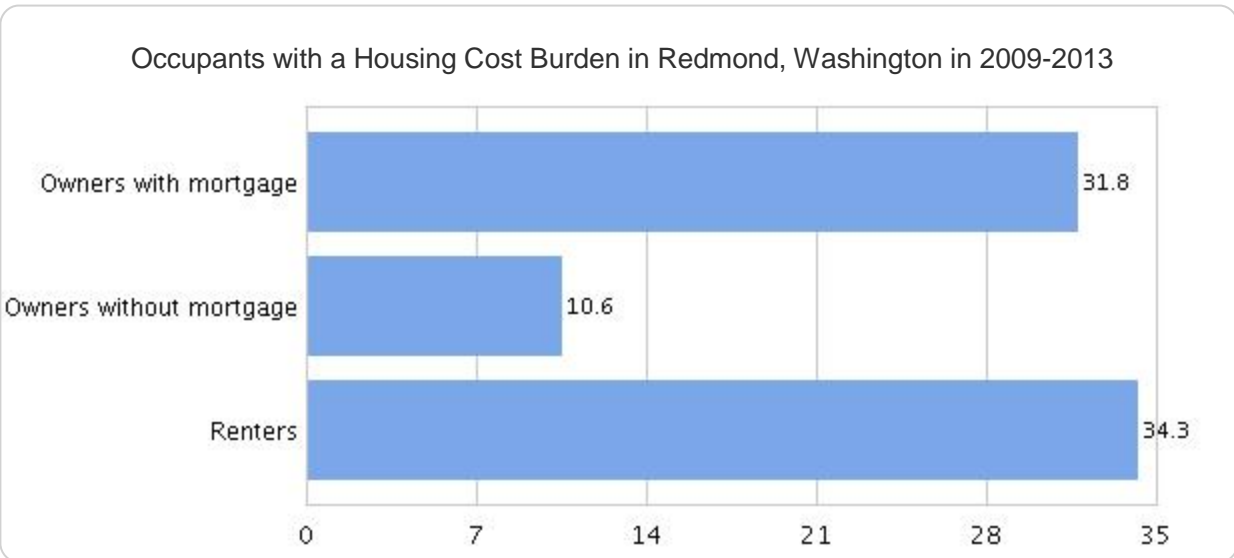
Homes in Redmond, Washington were heated in the following ways:

► **Housing Costs**

The median monthly housing costs for mortgaged owners was \$2,354, nonmortgaged owners \$716, and renters \$1,402. An estimated 32 percent of owners with mortgages, 11 percent of owners without mortgages, and 34 percent of renters in Redmond, Washington spent 30 percent or more of household income on housing.



Explanation of Symbols:

An '-' entry in the estimate column indicates that either no sample observations or too few sample observations were available to compute an estimate, or a ratio of medians cannot be calculated because one or both of the median estimates falls in the lowest interval or upper interval of an open-ended distribution.

An '-' following a median estimate means the median falls in the lowest interval of an open-ended distribution.

An '+' following a median estimate means the median falls in the upper interval of an open-ended distribution.
